NOTICE: FOR NMIS STUDENTS – ONLINE EXAMINATIONS IN SEPTEMBER 2020.

On 16th March 2020, a circular was sent to you stating that the Management had decided to **CANCEL** the papers which were to be conducted on 21st / 22nd March because of Covid situation prevailing.

Since the pandemic situation has still not improved and it is not possible to conduct the examination in the classroom. Furthermore, it is still not clear when the situation will be normalized to conduct the examination in the classroom.

Keeping in view the interest of the students and importance of examinations for promoting the students from 1st year to 2nd year and also to give the certificates to the students who clear all the papers of 1st & 2nd Year, the Management of NMIS has decided to conduct all the papers of 1st & 2nd year in the online mode.

These online examinations will be conducted through Wheebox platform. To familiarise you with the online examination, we will be conducting one “Mock Test”. The mock test will be conducted 1 week before the final examinations. The final examinations will be from Mid-September onwards.

We will be sending you “Candidate Manual” so that you read the same well before the commencement of the examinations to enable you familiarise with the process.

This examination is open to all the students i.e. those who have not appeared in March 2020 examination as well as for those students who have to clear some balance papers / ATKT. Those students who have paid the fee for March 2020 examination and are appearing for only those papers which couldn't be conducted are not required to pay any
